OFFICE ORDER

Sub: Change in configuration from 2x660 MW to 2x700 MW Coal Based Thermal Power Plant at village Nalash, in Patiala Distt., in Punjab - reg.

Sir,

This has reference to your letter no. NPL/RKS/MOEF/0237-10, dated 28.05.2010 requesting for amendment in the environmental clearance accorded by this Ministry vide its letter of even no. dated 03.10.2008 for enhancement in capacity from 2x660 MW to 2x700 MW.

2. The request has been examined and the following changes as mentioned under shall be made in this Ministry's letter of even no. dated 03.10.2008.

a) The configuration viz. 1320 MW mentioned in the subject matter and at para no.2, second line, shall be substituted by 1400 MW (2x700 MW).

b) After clause no. (xxvii), under para no.3 of this Ministry's letter of even no. dated 03.10.2008, the following shall be added:

(xxviii) No additional coal consumption beyond 5.8 MTPA (at 85% PLF) earlier envisaged for 2x660 MW and no additional land for the enhanced capacity shall be permitted.

(xxix) The project proponent shall upload the status of compliance of the conditions stipulated in the environmental clearance issued vide this Ministry's letter of even no. dated 03.10.2008, in its website and updated periodically and also simultaneously send the same by e-mail to the Regional Office of the Ministry of Environment and Forests.


xxx) Criteria pollutants levels including NO_x, RSPM (PM₁₀ & PM_{2.5}), SO_x (from stack & ambient air) shall be regularly

monitored and results displayed in your website and also at the main gate of the power plant.

7. All other conditions mentioned in this Ministry's aforesaid letter of even no. 03.10.2008 shall remain the same.

This issues with the approval of the Competent Authority.
