L&T Construction Wins Orders Valued ₹ 3572 Crore

Mumbai, Nov 27, 2017: The construction arm of L&T has won orders worth ₹ 3572 crore across various business segments.

Transportation Infrastructure Business:

The business has been awarded a prestigious contract worth ₹ 1358 crore for the construction of a new South Parallel runway, apron and associated works (taxiway systems, pavement, drainage works, ancillary buildings and associated infrastructure facilities) at the Kempegowda International Airport, Bengaluru, on EPC basis from Bangalore International Airport Limited.

The project scope consists construction of North Remote Stands, East Remote Stands, South Parallel Runway, Cross Field Taxiway and T2 Apron that are to be completed in phases.

This project reinforces L&T Construction leadership in the design and construction of world-class airports.
