

CII suggests TN to adopt economic agenda to drive investments, create jobs

Chennai, May 7: CII tells The Tamil Nadu unit of Industry body Confederation of Indian Industry (CII) on Thursday urged the new government to be headed by the DMK, to adopt an economic agenda that would bring in new investment and create jobs in the state in the wake of the COVID-19 second wave.

CII Southern region chairman C K Ranganathan said, “the new government in Tamil Nadu should lay special focus on public health infrastructure due to the pandemic shaking the whole nation”.

“CII recommends the new government to adopt an economic agenda which would drive investment and create employment opportunities for the people of the state,” he said in a press release.

Ranganathan, also the chairman of fast moving consumer goods company CavinKare Ltd, said some of the priority sectors that need special focus were agriculture, food processing, defence and aerospace, infrastructure among others.

The ease of doing business in Tamil Nadu was another area in which CII would be working

closely with the new government, he added.

“CII would push for an investor friendly policy regime to attract global players to start business in the State.” CII Tamil Nadu chairman S Chandrakumar noted that the pandemic has hugely impacted the livelihood of the people and the focus should be on creating large manufacturing hubs.

“Tamil Nadu is already a leader in the automobile industry and it is high time to start a medical device and pharmaceutical manufacturing hub”, he said.

DMK President M K Stalin will be sworn in as the Chief Minister of Tamil Nadu on May 7.

7.2 lakh Maruti cars reach customers via railways

Chennai, May 7: Maruti Suzuki India Limited has transported over 7.2 lakh vehicles using Indian railways in the past five years. In 2020-21, more than 1.8 lakh vehicles took the rail route for transportation, the highest-ever railway despatch by the Company, as against nearly 88,000 units in 2016-17. The increased focus on using railways has helped the Company offset over 3,200 MT of CO2 emissions, cumulatively.

L&T to provide 22 oxygen generators to hospitals

Chennai, May 7: In a bid to render helping hands during the ongoing pandemic, L&T will soon start delivering 22 oxygen generators to various hospitals in India, where the scarcity is most acute. These units will absorb air from the atmosphere before converting it into medical-

grade oxygen and pumping it into pre-existing pipes in the hospitals.

Of these, the parts of the first tranche of nine equipment will reach India by 9th May. These will be progressively delivered from 15th May to hospitals that are in acute need .

The units work on the plug-and-play principle. Once all the constituent parts are fabricated, the compressor allows the air to reach a particular pressure within a few minutes. The generator then starts pumping oxygen into pipes.

Each of the units has a capacity range from 1,000 litres per minute (LPM) to 500 LPM. A 1,000 LPM machine could service 100-plus beds simultaneously. The 500 LPM machine can potentially service 50-plus beds at any point of time.
