Closed first SLL of 107 million USD with SMBC based on climate targets










Increase in Energy Consumption Intensity & GHG Emission intensity in FY 2022 due to: Ramping up of construction activity post easing of Covid restriction



We have planted about 1.5 million trees in FY 2021-22. Target to plan 1.5-2 million per annum Todate, we have planted 6.2 million trees







